A Tribute to Craftsmanship: The Cromwell McNair Collection on Display at the Atlantic Wildfowl Heritage Museum

The Atlantic Wildfowl Heritage Museum is proud to showcase a remarkable tribute to one of America's most celebrated decoy carvers, Mark McNair, thanks to the extraordinary generosity of Mark and Margie Cromwell. The Cromwell's have graciously loaned their personal McNair collection to the museum for a rotating exhibit now featured in our downstairs gallery.


This exhibit is more than just a collection of carvings; it is the result of decades of admiration, personal friendship, and dedication to preserving American folk art. With 266 unique pieces on display, along with contributions of their own time, resources, and even furniture to help stage the exhibit, the Cromwell's have ensured that visitors will experience one of the most comprehensive displays of McNair's work ever assembled.

About the Artist

Mark McNair, born in 1950, has spent the last half-century

perfecting the craft of decoy carving. A graduate of the Rhode Island School of Design, McNair began his creative career in Connecticut, where he worked with antiques and hand-carved wooden signs. His life took a defining turn in the 1970s when he was introduced to antique decoys by the Voorhees family. What started as an interest quickly blossomed into a lifelong passion.

Today, McNair lives and works on Virginia's Eastern Shore, nestled between Chesapeake Bay and the Atlantic Ocean. His pieces ranging from waterfowl and shorebird decoys to weathervanes and folk art—are widely regarded for their authenticity, craftsmanship, and unique character. His work is represented in numerous distinguished collections, including those at the Shelburne Museum in Vermont, The Ward Museum of Wildfowl Art in Salisbury, Maryland, and right here at the deWitt Cottage in Virginia Beach. McNair's legacy continues through his family's legacy. Of his three children, Sons Ian and Colin followed in his footsteps. Ian carves in Exmore, Virginia, and co-owns High 'N Dry, a company producing rugged chest waders. Colin is



A Friendship Carved in Time

The story behind the Cromwell's' collection is just as meaningful as the art itself. Mark Cromwell first met Mark McNair in 1978 while helping his parents move furniture for their antique business on the Eastern Shore. It was during this visit that Mark Cromwell laid eyes on one of McNair's decoys and instantly knew he wanted

to start a collection. There was only one obstacle; he didn't have the money to buy one. Thinking creatively, Cromwell struck a deal with his parents:

instead of being paid for his help, they would



purchase McNair decoys for him. That simple exchange sparked not just a collection, but a friendship and mutual respect that has lasted nearly 50 years.

We invite you to visit the museum, explore the Mark McNair exhibit, and immerse yourself in the artistry, history, and stories behind these extraordinary works.



Collector's Shelf



JOHN TREAT IRVING, Jr. (1812-1906)

The Currituck Shooting Club (the 'Currituck Club') was founded by wealth New Yorkers on the Outer Banks in

1854, in the budding years of the Gilded Age. It was the first recorded club of its type on Currituck Sound. Obviously, the club had to take a hiatus during the Civil War (1861-65), when these gentlemen would have been 'persona non grata' in the South. However, the founding members did get to enjoy the excellent waterfowling on Currituck Sound during those few early years. One of the club's founding members was John Treat Irving, Jr., the namesake son of a successful lawyer, judge, and New York State Assemblyman. John, Jr.'s father was also the brother of well-known American author Washington Irving (*Rip Van Winkle, The Legend of Sleepy Hollow, etc.*), who first popularized the writing of short stories in our country's early years.

Our John, Jr. followed in his father's footsteps in studying law and in his uncle's footsteps as a prolific author. In 1828 at the age of 16, he graduated from Columbia College (now University) with interests in law, real estate, and stockbroking. He became actively engaged and successful in each of these professional endeavors. However, his true interests were in writing and



adventure traveling. In 1833 at age 21, he joined a party led by Indian Treaty Commissioner Henry L. Ellsworth to visit the 'wild Indian tribes of the prairie.' (His uncle, Washington Irving, had accompanied Ellsworth on a similar trip the previous year.) Their objective was to forge a treaty with the Pawnee Indians who inhabited what is now northern Kansas and Nebraska. This adventure led to John, Jr.'s first book, *Indian Sketches* (1835). His second novel, *The Hunters of The Prairie, or The Hawk Chief: A Tale of Indian Country*, followed two years later. Each of these works were said to express his uncle Washington Irving's 'gentlemanly concern for the frontier.' These early writings were followed by additional publications, leading to John, Jr.'s membership in the Authors Club and other prominent New York clubs.

Of equal interest, John, Jr. was married to Helen (Schermerhorn) Irving (1829-1893). Helen was the sister of Caroline (Schermerhorn) Astor (1830-1908), the "Lady Astor" and matriarch of New York's Gilded Age society. One presumes this would have automatically included John, Jr. and Helen in our previously mentioned Ward McAllister's "400," the exclusive level of New York socialites able to comfortably fit in the ballroom of Lady Astor's 5th Avenue chateau. For those even having a chance, acceptance into the "400" was an aspiration actively sought. For those aspiring to be included, failure to receive an invitation to one of Lady Astor's balls was devastating. Those left out would routinely manufacture excuses such as having to, instead, attend a grandparent's funeral (some grandparents passed multiple times) or travel to the Catskills for health reasons.

I find it nothing short of amazing that these scions of the Gilded Age were drawn away from their comfortable lifestyles to what must have been at the time the wild and remote sportsman's paradise of the Outer Banks. It remains a rich history left largely untold.


